Limca Book of Records-For Most squint surgeries performed

Most squint surgeries performed

Pune Netra Seva Pratisthan's 106th free surgical squint camp was held at Ayurved and General Hospital, Nigdi, Pune, under the aegis of Rotary Club of Chinchwad, Pune on August 14 -15, 2010. A team of eight surgeons and seven anaesthetists under the guidance of Dr Madhusudan Jhamwar, chief eye surgeon, performed 157 surgeries on four operating tables. The

beneficiaries were poor patients. The other surgeons were Aarti Kabra, Vishal Vidhate, Paras Shah, Sachin Gade, Ramesh Bhangre, Sanjeev Rathod, Suvarna Golecha and Sachin Kabra.

Eighteen screening camps were held all over Maharashtra prior to the surgical camp, during which 2,500 patients were checked for squints. Of these 175 were ear-marked for surgery.
